Lapsed members who do not pay the fee will have Subscriber status until the late fee is paid. Membership will be automatically terminated if dues remain unpaid for 60 days after start of the fiscal year. After March 1, members wishing to rejoin will be required to fulfill the club's membership application requirements (attendance and/or volunteering at two events, and sponsorship by two members in good standing), with a vote at a regular club meeting, before being reinstated.
